In addition to requiring the involvement of everyone in the organisation we also believe that good HS&E performance is dependant upon a process of Continuous Improvement. Therefore we are:

### 1. EFFECTIVELY MANAGING HS&E BY:

- Ensuring that HS&E is an integral part of the way we do business
- Making people responsible and accountable for activities required to implement this policy
- Using Quality Management principles in the implementation of our Continuous Improvement Plan
- Communicate openly with our employees and customers on our HS&E programmes and performance

### 2. REDUCING HS&E RISK BY:

- Identifying and assessing HS&E hazards, and by preventing, controlling or reducing risk to the lowest practicable level
- Regularly reviewing our working methods and industry best practice to identify opportunities for improvement

### 3. INVOLVING AND CONSULTING WITH OUR WORKFORCE BY:

- Providing them with appropriate HS&E information, instruction, training and supervision
- Encouraging their participation and ideas in improving our HS&E performance
- Commending good HS&E performance
- Listening and addressing their concerns about HS&E issues

### 4. COMPLYING WITH LEGISLATION, CODES OF PRACTICE AND STANDARDS BY:

- Keeping abreast of, interpreting and complying with relevant laws, regulations, codes of practice and industry standards, and by taking any additional measures we consider necessary
- Working with our industry, our customers and the relevant enforcing authorities to influence effective legislation and standards
